The Chairman will introduce the Interim Parish Clerk and new Members of the Council. The Clerk will circulate the forms for The Declaration of Members Interests, to be completed by all Members within 28 days of election.

## 8. REVIEW AND ADOPTION OF POLICIES, PROCEDURES AND PROCESSES.

In addition to the above issues Members are required to review and adopt the following:

- To review and adopt Standing Orders and Financial Regulations. The Standing Orders were revised in 2021 to accommodate the Covid Regulations and both documents can now revert to that adopted in May 2019.
- ii) To review and adopt a Risk Management and Assessment Policy. This was last reviewed and adopted in May 2019. It remains unchanged and needs to be adopted ahead of the internal audit process.
- To review and adopt a process for dealing with requests under the Freedom of Information Act 2000. The Council follows the guidelines laid down in the Act.
- iv) To review and adopt policies under the Data Protection Act. These were revised under the General Data Protection Regulations, which came into force on 25th May 2018.
- v) To review the Council's inventory of land and assets. This is carried out as part of the Annual Return process in June each year.
- vi) To consider insurance cover. This is carried out at the June meeting at the time of renewal.
- vii) To review and agree subscriptions to other bodies on behalf of the Council or its staff. This includes a Data Controller fee to the IOC under the new GDP Regulations and subscriptions to C.D.A.L.C. and The S.L.C.C.
- viii) To review and adopt the Council's policy on Parish Polls, which was adopted at the last AGM.

- To review and adopt the Code of Conduct for Members which was last the subject of training and adoption in 2018.
- Powers of Competence. This power, which allows qualifying Parish Councils to act in any way that an individual may do, came into effect in February 2012. The qualifying criteria are that at least two thirds of Members are elected and the Clerk holds a relevant level of training. The new Parish Council qualifies to use these powers and should it decide to adopt them, it would no longer need to use \$137 of the Local Government Act to cover expenditure on Remembrance Sunday or to support Cornforth Partnership.

#### 9. CO-OPTED MEMBERSHIP.

The full Cornforth Parish Council can comprise 15 Members. At present only eleven candidates have been returned unopposed. The Council needs to consider if it wishes to co-opt four further Members. If it so decides, it is recommended that it advertises its intention widely and undertakes due diligence on potential candidates. NALC provides a useful template to be signed by potential co-optees and can advise in this respect.

Members are reminded that they must complete a declaration of pecuniary and other interests within 28 days. The form has been circulated with this agenda and members are advised to return it to the Parish Clerk (Mr. Snowball) as quickly as possible.
